

**Applicants must meet all Tuition Relief Qualifications:**

1. Must have limited financial resources or demonstrated financial need.
2. Must have access to reliable transportation to and from class each day of the Academy.
3. Must be able to attend all days of the Summer Academy program. No refund of any fees paid will be available to participants not attending class each day of the Academy.
4. Must be registered with \$50.00 registration fee paid by April 21, 2017.
5. Demonstrated academic merit – letter from your high school counselor on High School letterhead with counselor’s original signature stating your current academic rank* and with Parent/Guardian signed grade/rank release permission. Letter must include:
 - a. Student Name and Academic Rank
 - b. Name and Signature of high school counselor (with date)
 - c. Permission text: “I give permission for X High School to release grade/rank information to UTSA Summer Academy for my son/daughter (name)

2. Tuition Relief application must be received by April 21, 2017. The applicant must also be registered w/\$50 registration fee paid. If, for any reason, you do not receive financial assistance for tuition and you need to request to withdraw registration, the registration fee will be refunded to you in full.
3. Applicant agrees to attend the entire Summer Academy program. There is no refund for partial attendance.
